## RULES OF CONDUCT

These Rules of Conduct are established to maintain a positive and respectful environment within the Club, ensuring the well-being and enjoyment of all members.

### I. Introduction

*Purpose:* The Tri-City Singles and Friends Social Club ("the Club") is established as a social group with the primary objective of fostering camaraderie and social interaction among its members. It is explicitly not a dating service.

### II. General Conduct

*Non-confrontational Discussions:* All discussions within the Club must be non-confrontational and conducted with respect and a spirit of camaraderie. Members are expected to treat each other with courtesy and consideration.

*No Solicitation:* Members are strictly prohibited from engaging in any form of solicitation with or from fellow club members at any time. This includes but is not limited to commercial, promotional, or personal solicitations.

*Privacy and Confidentiality:* Members shall adhere to a strict policy of not disclosing or distributing another member's phone number at any time.

### III. Decision-making and Governance

*Board Intervention:* Individual board members do not have the authority to make unilateral decisions or interventions in any situation. All concerns, disputes, or proposed changes must be brought to the attention of the entire board for collective consideration.

*Unanimous Consent:* Any decisions, changes, or interventions requiring the involvement of the board must be reached through unanimous consent. The board will deliberate and vote on matters presented to ensure a fair and equitable resolution.

### IV. Club Functions

*Saturday Post Lunches:* Post lunches held on Saturdays are considered non-club functions and are open to all, members, and non-members alike, providing an opportunity for casual and inclusive socialization.

By becoming a member of the Tri-City Singles and Friends Social Club, individuals acknowledge and agree to abide by these Rules of Conduct, contributing to a positive and enjoyable social environment for all members.
